

# Merck Gave \$56,000 To The Sedition Caucus After Two of Its Leaders Considered Withholding Contributions From Election Rejectors Before Jan. 6—With One Saying "We Have To Create Some Level Of Cost" For Them

**SUMMARY:** Merck gave \$56,000 to the Sedition Caucus although the company has touted a "[commitment to unwavering ethics and integrity](#)," and has postured itself as "[positive change agents](#)" in "[addressing critical social issues](#)."

An Accountable.US review has found additional information that further complicate Merck's contributions to the anti-democratic lawmakers who sought to overturn the 2020 election:

- The day before the insurrection on January 6, 2021, Merck's then-CEO (who is now Executive Chairman) and a board member [participated](#) in a call among major business leaders considering withholding contributions to Republicans who sought to undermine the presidential transition...
- ...The Merck board member on the call, who has since been [named](#) an Independent Lead Director, has bluntly said, "[we have to create some level of cost](#)" for election rejectors, adding "[money is the key way](#)."
- Merck's then-CEO and now Executive Chairman [led two major efforts](#) to oppose state voting restrictions advanced by Republicans after Trump's 2020 loss—citing the insurrection, the CEO said, "[it's a mistake for corporations to take democracy for granted](#)."
- Merck claims that it [recognizes](#) the United Nations Universal Declaration of Human Rights, which emphasizes [democratic rights](#), and the United Nations' Global Compact, [which](#) guides companies on respecting the rule of law—and even highlights a case example of a company helping to [prevent "violence" and "promote stability during elections"](#).

**January 5, 2021: Merck's Then-CEO And Current Executive Chairman Ken Frazier Participated In A Call Among Chief Executives Who Were Considering Withholding Contributions To Republicans "Seeking To Impede The Presidential Transition."** "In a virtual gathering of chief executives convened to discuss political turbulence stemming from the 2020 election, leaders of some of the largest U.S. companies said they were considering withholding donations to Republican lawmakers seeking to impede the presidential transition. During an hourlong meeting Tuesday, a group of about three dozen chief executives discussed divisions in the country, efforts to thwart the presidential transition and what voice they thought business should have in politics, according to people who participated in the conversation."
